MINUTES OF UEF MEETING HELD ON 18 SEPTEMBER 2014

AT 13H00 – GREAT WHITEHOUSE, KLEINBAAI

1. Welcome

MG welcomed all present. He apologized for not being more involved in his role as chairperson of the UEF due to other commitments. MG will stay on as the Chairman and PdV was appointed as the Vice Chairman, it was accepted by all. DC noted that the Overstrand Municipality will provide admin support to the UEF through HF.

MG informed all that the letters went out but we need confirmation as to whether all the bodies did complete it. PdV and HF will follow up who the representatives of each body is.

8. **Management Forum Constitution**

PdV informed all that the Cape Estuaries Programme was driven by a unit within CapeNature, now the Western Cape Province has taken on Estuary Management and they are setting up a programme which will go out on Tender and in that they will develop a standard forum grouping as to who needs to be in the forum and a standard basic constitution. The Estuary Management Plan will be reviewed and finalized by DEA so that it can be adopted by local municipalities and the Minister. These three processes will happen within the next 6 months.

WK did follow up with their National office there seems to be a misunderstanding with regards to where the documentation is. She suggested a meeting with Barry, their national office, themselves and Pierre to finalize this point.

MG informed all that the alien clearing in general in the Walkerbay Conservancy is going well. Alien clearing on the banks of the Estuary has to be done. The landowners on the banks of the Estuary are CapeNature, Overberg District Municipality and 1 private landowner (Game Farm) MG will get contact details and forward to PdV. PdV will follow up with CapeNature and provide feedback at the next meeting on the way forward. BK noted that on the left hand side towards Gansbaai the land belongs to ODM. BK will get contact details of all the landowners and to give to MG.
