6. MBD 6.2. – DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT FOR DESIGNATED SECTORS

Introduction

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

Before completing this declaration, bidders must study the:

- General Conditions,
- Definitions,
- Directives applicable in respect of Local Content as prescribed in the Preferential Procurement Regulations, 2017; and
- South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 (Edition 1)⁴ and the Guidance on the Calculation of Local Content together with the Local Content Declaration Templates
 - Annexure C- Local Content Declaration: Summary Schedule,
 - Annexure D- Imported Content Declaration: Supporting Schedule to Annex C and
 - Annexure E- Local Content Declaration: Supporting Schedule to Annex C.

1. General Conditions

- 1.1 Preferential Procurement Regulations, 2017 (Regulation 8) makes provision for the promotion of local production and content.
- 1.2 Regulation 8.2) prescribes that in the case of designated sectors, where in the award of bids local production and content is of critical importance, such bids must be advertised with the specific bidding condition that only locally produced goods, services or works or locally manufactured goods, with a stipulated minimum threshold for local production and content will be considered.
- 1.3 Where necessary, for bids referred to in paragraph 2.1 above, a two stage bidding process may be followed, where the first stage involves a minimum threshold for local production and content and the second stage price and B-BBEE.
- 1.4 A person awarded a contract in relation to a designated sector, may not sub-contract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 1.5 The local content (LC) expressed as a percentage of the bid price must be calculated in accordance with the SABS approved technical specification number SATS 1286: 2011 as follows:

$$LC = [1 - x / y] * 100$$

Where

x is the imported content in Rand

y is the bid price in Rand excluding value added tax (VAT)

Prices referred to in the determination of x must be converted to Rand (ZAR) by using the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid as required in paragraph 4.1 below.

1.6 A bid may be disqualified if:

- (a) this Declaration Certificate and the Annex C (Local Content Declaration: Summary Schedule) are not submitted as part of the bid documentation; and
- (b) the bidder fails to declare that the Local Content Declaration Templates (Annex C, D and E) have been audited and certified as correct.

2. Definitions

- 2.1 **“bid”** includes written price quotations, advertised competitive bids or proposals;
- 2.2 **“bid price”** price offered by the bidder, excluding value added tax (VAT);

12. SPECIFICATIONS

1. INTRODUCTION / BACKGROUND

- 1.1 The municipality has a large number of irrigation systems in gardens, parks, sport fields and open spaces within the Overstrand municipal area, which needs to be maintained and repaired.
- 1.2 The services of a competent- and experienced service provider is therefore required to repair-, maintain on an as and when basis.

2. SCOPE

- 2.1. The repair and maintenance of irrigation systems on an as-and-when basis in the Overstrand, for the period ending 30 June 2023.

3. GENERAL

3.1. Contract period

8. TECHNICAL REQUIREMENTS

8.1. General

- 8.1.1. The Municipality will have the right to use the IRRIGATION REPAIR items to maintain any irrigation system located in any landscaped area owned by the Overstrand Municipality in the Hermanus area as well as any irrigation system installed after the award of this contract.
- 8.1.2. The Contractor will issue a report to the relevant official describing the maintenance and any repairs or replacements required that fall outside the scope of the monthly service contract, within forty-eight (48) hours of performing maintenance functions.

8.2. Monthly Service Contract

- 8.2.1. Any repair work that is not specified as routine maintenance and that is identified by the Contractor will be performed and paid for in accordance with the IRRIGATION REPAIR item. This repair work must be authorized by the relevant municipal official.
- 8.2.2. The Contractor is required to monitor each irrigation system on a monthly basis (or as specified by the municipality) for functionality (including adjustment of timers, moisture sensors, and all alternatively associated mechanisms) to ensure that proper water quantities are applied, at the best duration and time of day for each plant group.
- 8.2.3. Maintenance operations will include but will not be limited to:
 - i. Testing of all zones.
 - ii. Cleaning of clogged water outlets, spray nozzles and filters.
 - iii. Trimming of plants or grass around water outlets and valve boxes.
 - iv. Verifying activation of each solenoid valve.
 - v. Inspecting all wire connections within valve boxes related to these solenoid valves.
 - vi. Inspecting and adjusting (if necessary) all wire connections within each irrigation controller and valves.
 - vii. Testing entire system for overall performance.
 - viii. Observing for visual evidence of water leaks.
 - ix. Making necessary adjustments including head, valve, and controller adjustments.

- 8.2.4. The Contractor must include in the tendered rate per station for all supervision, labour, plant, equipment, transport.

8.3. Irrigation Repair

8.3.1. Detailed report before repair

Prior to commencing with any repairs, the successful Contractor must submit a detailed report and/or detailed quotation for approval, indicating the parts to be replaced and specifying the estimated number of hours (labour) required. The cost of producing said report will be for the account of the service provider and no additional payment will be made.

8.3.2. Labour

The bidder must include in the rate per hour tendered, for all supervision, labour, plant, equipment, and incidentals required for the satisfactory completion of the work.

8.3.3. Materials

Where repairs need to be made the Municipality must authorize all the purchases of materials by the Contractor. The Contractor may purchase materials directly from the agents at the actual cost price plus 10% (ten percent) of the current list price. It will be expected of the service provider to prove costs of all purchases in excess of R2000.00. The Municipality reserves the right to obtain other quotations and/or purchase the materials elsewhere if the price is deemed too excessive. No further adjustments for escalation will be made.

8.3.4. Ordering procedure for the repairs to an irrigation system:

8.4. Establishment

8.4.1. The Contractor must ensure that an acceptance note, or job card is signed by an authorized municipal official for each repair job, without which no payment will be processed. In this regard the tenderer will have to acquaint themselves with the relevant staff on site and recognised working hours and holidays of the Overstrand Municipality. Notwithstanding the above clause the Contractor can effect application outside working hours by arrangement with the Project manager.

8.4.2. The successful contractor will be required to commence with the work on site within 2 days of the date of an official order unless otherwise arranged with the Municipal Project manager, failing which a penalty of R250/day will apply for each day in breach.

8.4.3. Time for repairs will be measured from arrival on site until the contractor has effected the repairs and leaves the site.
